DEAR FRIENDS,

FACT is working to change the narrative about family farming and what the future of farming should look like. For too long industrial farming businesses have controlled this narrative. We believe the future of farming needs to change from a focus on commodities such as corn and soybeans to one focused on raising animals humanely and growing food that people can eat.

We work with a network of nearly 12,000 farmers, many of them young and beginning farmers, who share our vision for the future of farming.

They believe in producing food for their local communities and finding ways to make a living from farming. We at FACT believe the future of farming is in helping these farmers achieve their dreams.

During this past year, FACT continued to positively impact farmers and farming across the country through our farmer programming. Our Fund-a-Farmer grants and scholarships support farmers financially. Our free webinars and Humane Farming Online School educate thousands yearly. Our Mentorship program offers new and beginning farmers the chance to learn directly from more experienced farmers. We are making a difference.

We have worked to guarantee that food raised from animals is safe and healthy. FACT is the lead organization nationally that has been calling on the U.S. Food and Drug Administration (FDA) to ban the carcinogenic drug carbadox, which is still given to most pigs raised in confinement in the United States.

In December we finally made progress when the FDA announced their plan to ban this drug.

We continue to lead the Keep Antibiotics Working Coalition in an effort to reduce the amount of antibiotics given to food animals by 50%.



We hold the FDA and factory farms accountable and demand action.

Our partners and supporters participate in our action alerts by signing petitions and reaching out to their legislators and to the FDA and USDA. These actions bring about positive results.

There are many challenges ahead. We believe that together we can work to transform our food system. It should be a system that:

- Feeds communities healthy and humanely raised food that is accessible to all.
- Is regenerative, that is good for the soil and for the planet.
- Prioritizes small, young, and beginning farmers over large, multinational, industrial factory farms.
- Prioritizes treating animals raised for food humanely and with respect.
- All food from animals must be safe and healthy for people to eat.

HUMANE FARMING

FACT's Humane Farming program partners with and invests in individual farmers who are seeking to raise their animals humanely by providing them with grants, scholarships, webinars, training, and other learning opportunities.

FUND-A-FARMER GRANTS

In April 2023 FACT awarded

87 grants

totalling more than

to farmers and ranchers located across

33 states

This year saw the highest number of grants we have awarded since the program started in 2012. The grants were awarded for projects that improve farm animal welfare and increase the capacity of humane farmers.

In April of 2024, we will award at least \$250,000 in grants benefiting more than 80 farms. Since 2012, FACT has cumulatively awarded 608 grants totaling over \$1,110,000 to farmers across 44 states, directly benefiting an estimated 978,000+ animals.



HUMANE FARMING MENTORSHIP PROGRAM

ADVOCACY

We signed onto dozens of organizational letters in support of increased funding for conservation programs and sustainable agriculture research, climate change mitigation, and protections for food and farm workers.

We brought 13 farmers to D.C. for the Farmers Climate Action: Rally for Resilience

And participated in 18 meetings with Congressional offices and the USDA.

We urged policy makers to support grazing, local meat processing, and climate solutions in the Farm Bill.

PROGRESS IN OUR FIGHT TO BAN THE DEADLY FEED ADDITIVE, CARBADOX

In November, just weeks after FACT delivered 2,359 petitions from our supporters to the FDA Commissioner calling for FDA to ban the cancer-causing pig drug carbadox, the agency announced it intended to ban the drug. Over half of the pigs raised in the U.S. are fed carbadox, a drug banned in countries around the globe because feeding it to pigs leads to carcinogenic residues in pork. FACT has been the primary organization pushing to get the FDA to ban carbadox.

FACT HAS BEEN PUSHING FOR THIS POLICY CHANGE ALL YEAR

August 23

FACT released our "Poisonous Pork" report that showed that carbadox is the most common residue detected in random sampling of pork by U.S. Department of Agriculture (USDA) - exposing thousands of people to dangerous amounts of cancer-causing residues every year. Some of the residues detected were over 10,000 times higher than the level determined by the FDA to be safe.

October 4

FACT met with USDA officials to discuss how much carbadox was being used on the giant facilities where most pigs are raised.

October 24

FACT delivered 2359 petitions to the FDA Commissioner calling for a ban on the drug.

October 27

FACT and pasture-based pig farmer Greg Gunthorp met with USDA officials to discuss testing of pork for carbadox.

December 7

FACT drafted comments signed by 14 organizations calling on the FDA to move forward with a carbadox ban and not grant a hearing to the drug maker.

The most common residue violation found by USDA in pork is the carcinogen carbadox.



FDA is working to withdraw the method used by USDA to detect carbadox residues in pork because it is not sensitive enough.

Even with the weak method, USDA residue testing data suggest that an estimated 390,000 servings of pork with cancer causing carbadox residues are served each year.



Because the method is too weak, many more servings of cancer causing pork are likely being served.

Earlier in the year, FACT focused on getting food companies to do more to require their pork suppliers to stop using the cancer-causing drug, carbadox. While an FDA ban will stop everyone from using the drug, company action can happen more quickly than the FDA's cumbersome requirements to ban a drug.

June

FACT met with staff from Starbucks to discuss carbadox. This followed outreach by letter and an email campaign targeting Starbucks in March which culminated in a social media push in June.

October FACT met with representatives from food service company, Aramark to discuss carbadox.

OUR FIGHT AGAINST FACTORY-FARM-RAISED SUPERBUGS



antibiotic-resistant infections. They are on track to become more deadly than cancer by 2050.

- The giant U.S. meat industry runs on antibiotics, which allows unhealthy and inhumane treatment of animals in facilities and feedlots where tens of thousands of animals are housed.
- The overuse of antibiotics on factory farms causes the creation of antibiotic-resistant superbugs that lead to difficult-to-treat illness for both people and animals. In addition to producing huge amounts of inhumanely raised meats, these giant livestock facilities are factories for deadly difficult-to-treat illnesses. That is why FACT has been working toward a reduction in the use of antibiotics in agriculture.
- · Unfortunately, the latest data show that the US is moving in the wrong direction. Factory farms keep getting bigger and their use of antibiotics keeps going up.
- Comparing 2022 to 2018, the use of antibiotics in meat production adjusted by the weight of animals sold increased by 22% in turkeys, 10% in pigs, and 2% in cattle. Only in chickens, which already use drastically less antibiotics, was there a 36% drop.
- The FDA is required by law to make sure that animal drugs do not harm human health, but they move too slowly when it comes to protecting people from antibiotic-resistant superbugs.
- More and more the FDA is placing the interests of the meat industry over the protection of public health. We spend a lot of time trying to get them to make protecting people their primary job.

FDA ACTIONS IN 2023 AIMED AT STOPPING THE SPREAD OF SUPERBUGS

June

The FDA set new rules that require that all antibiotics related to drugs used in human medicine require a veterinarian's order before use in food animals.

August

The FDA asked for feedback on a plan to collect data from livestock-raising facilities, but like the effort to stop the continuous use of antibiotics, this plan places the meat industry in charge.

September

The FDA issued a draft plan to require animal drug makers to prohibit the continuous feeding of antibiotics to food animals. We have been asking for the FDA to do this, but the FDA's current draft allows the continued use of antibiotics for very long periods with no concern for human health impacts of long uses.

FACT worked with our allies in Keep Antibiotics Working (KAW) to put pressure on the FDA and other branches of the government to do a better job protecting people from resistant superbugs. FACT leads KAW, a coalition of 19 advocacy organizations working together to stop the spread of superbugs.



FACT met with federal officials (the FDA, USDA, and White House) eight times during the last year to push for greater action on antibiotics.

We sent written comments and letters to federal policymakers ten times during the last year asking for more action on antibiotics.



We ran five action alerts with FACT supporters asking for greater action on antibiotics. Thanks to all of you who participated. Our action alert system allows our constituents to personalize their comments.

In January, FACT joined a lawsuit challenging the FDA's failure to protect the public from the overuse of antibiotics by the meat industry.






FACT staff went on a podcast tour in June where we spent two days getting our message about antibiotics out on 10 different podcasts. We also published 16 blogs on the superbug problem.




